TERMS AND CONDITIONS OF ENTRY

The Promoter of this prize draw (the **Prize Draw**) is Banner Group Limited trading as Staples (**Staples, us or we**), a company registered in England and Wales under company number 05510758 and whose registered office is at 1st Floor, 1 Europa Drive, Sheffield, S9 1XT.

Staples is offering you the chance to win PlayStation Five (the **Prizes**) as described and as set out in these terms and conditions of entry (**Terms and Conditions**).

By entering into the Prize Draw, all entrants accept and shall be bound by and will be deemed to have accepted and be bound by these Terms and Conditions. All entry instructions issued by or on behalf of Staples (via its website at www.staples.co.uk (the **Website**) or otherwise) shall form part of these Terms and Conditions.

1 ELIGIBILITY

- 1.1 The Prize Draw entry period will run from midnight on 13th November 2023 to 23:59 13th December 2023 (the **Prize Draw Entry Period**). Entries received after the Prize Draw Entry Period will not be eligible for inclusion in the Prize Draw.
- 1.2 Customers who place eligible orders via the Website during the Prize Draw Entry Period can qualify for entry to the Prize Competition. Customers who purchase multiple products from the qualifying brands will receive one (1) entry into the Prize Competition for each product purchased. Therefore, the number of entries corresponds to the number of distinct products from the qualifying brands included in the purchase. (there are no minimum requirements as regards the value of such orders)
- 1.3 Orders must include any Exacompta, Sharpie, PaperMate, Avery, Leitz or Post-It branded products to be eligible for entry to the Prize Competition. A list of all eligible products is available on request from marketing@staples-online.co.uk. Any orders which do not include eligible products will be disqualified from the Prize Draw.
- 1.4 This Prize Draw shall only be open to users of the Website who are aged 18 years or over and who are resident in the United Kingdom mainland. The Prize Draw is not open or available to residents of Northern Ireland.
- 1.5 Employees or close family members of Staples, any supplier to Staples, or any person otherwise connected with the organisation of the Prize Draw are not eligible to take part in the Prize Draw.
- 1.6 It is the responsibility of the entrant to provide their correct, up-to-date details when entering the Prize Draw and/or confirming acceptance of the Prize. Staples cannot be held responsible for winners failing to supply accurate information which affects their entry into the Prize Draw or delivery of the Prize.

2 THE PRIZES

- 2.1 The prize is **ONE of FIVE** PlayStation Five's. The Prize is not transferable or exchangeable and cannot be redeemed for monetary value or for any other form of compensation.
- 2.2 The Prizes are as stated and are not transferable or exchangeable. There is no cash alternative to the Prize. We reserve the right to substitute any Prize with another of equivalent or greater value without giving notice in the event that the Prize is unavailable for any reason.

3 THE PRIZE DRAWS

- 3.1 The Prize Draws will take place within 5 working days of the end of the Prize Draw Entry Period.
- 3.2 The winners will be selected at random from all eligible entries and the Prize Draws will be managed and overseen by an independent adjudicator. Details of the independent adjudicator are available on request.

4 THE WINNERS

- 4.1 The winners will be notified via the email address they provided on entry into the Prize Draw within 5 working days of the Prize Draw taking place and will be required to respond to confirm eligibility and acceptance of the Prize within 10 working days of such notification. The winners will be contacted via Staples from the following email address marketing@staples-online.co.uk only. If the winner does not respond to the initial contact within 10 working days, Staples reserves the right to disqualify the winner. If the winner is disqualified, we reserve the right to award the Prize to an alternative winner selected in the same manner.
- 4.2 Provided no objection is received, if you are a winner, your surname and county of residence will be made available by Staples to anyone sending an email request to marketing@staples-online.co.uk up to eight weeks after the end of the Prize Draw Entry Period. If you are the winner you can object to your surname or county of residence being published or request for the amount of information being published to be reduced. Staples is required to provide this information to the Advertising Standards Authority on reasonable request.
- 4.3 Staples may request that the winner participate in publicity arising from the Prize Draw. The winner is under no obligation to participate and may decline this request. Participation in such publicity is at the winner's discretion, subject to their express consent which will be obtained via a separate agreement, and is not a condition of entry into the Prize draw or Prize acceptance.

5 LEGAL

- 5.1 Staples reserves the right to cancel or amend the Prize Draw and these terms and conditions without notice in the event of a catastrophe, war, civil or military disturbance, act of God or any actual or anticipated breach of any applicable law or regulation or any other event outside of the its control. - 5.2 Staples and its partners and suppliers are not liable and shall not be liable for any change, compensation, cancellation, loss, damage, expense or failure to perform the Prize Draw which is due to any event or circumstances which Staples (or its partners or suppliers) could not foresee or avoid, or which is caused by or arises as a result of any act or omission by any other party.
