

## **STAPLES – FESTIVE CRAFTS COMPETITION – TERMS & CONDITIONS OF ENTRY**

1. 1. “**Staples**” means (and is the trading and operating name of) Banner Advantage Ltd company registered in England and Wales under company number 12740681 and whose registered office is at 1st Floor, 1 Europa Drive, Sheffield, S9 1XT. “**Festive Crafts Competition**” means the competition of winning **1 (ONE) £250 voucher of choice for the child and 1 (ONE) £1,000 voucher to spend at Staples.co.uk for the school of the child by 3 (THREE) winners and 10 (TEN) children in total across all three categories receiving art packs** as described and as set out in these terms and conditions of entry. “**Terms and Conditions**” means these terms and conditions of entry.
2. By entering into the competition, all entrants accept and shall be bound by and will be deemed to have accepted and be bound by these Terms and Conditions. All entry instructions issued by or on behalf of Staples (via its website or otherwise) shall form part of these Terms and Conditions.

13. **10 (TEN)** highly commended entries from across the **3 (THREE)** categories will be drawn on behalf of Staples under independent supervision from all valid entries received.
